were once housed in the dozens of city buildings either destroyed or damaged by Hurricane Katrina.

"Nobody has to hit us between the eyes with a two-by-four to understand that we're going to have to do things differently when it comes to rebuilding and repairing the city's damaged or destroyed buildings," Director of Administration David Staehling says.

"It's important that the city foster sound policy to minimize the risk of future loss of municipal-owned property and assets."

The city's approach, Staehling said, is two fold:

"First, we must elevate and harden the reconstruction of all properties wherever possible to mitigate loss from future storms.

"Second, because of the extremely high cost of flood and wind insurance, plus the increased cost of construction, we must consider two options: relocating destroyed buildings away from flood zones and to higher ground, constructing buildings to house multiple uses to reduce management, staffing, maintaining and operational costs."

The city hopes to accomplish the goals by using insurance proceeds, hazard mitigation funds from FEMA and MEMA, and economic development grants from the Mississippi Development Authority.

"As we receive funding commitments from these agencies, we're proceeding with engineering and design work on each project."

Said Staehling: "Rebuilding in this responsible fashion and maximizing the available funding from federal and state levels

City finances show stability, signs of encouragement

For a city that was spending more money than ever in the months after Katrina, at a time when it was taking in less revenue than at any other time in the past 15 years, Biloxi is in good shape financially these days, Mayor A.J. Holloway says.

"That's because in the immediate wake of the storm, we suspended many of the capital projects that were on-going or planned for 2006," Holloway said. "We restricted normal operating expenditures. We took advantage of the help offered by the federal and state governments and we fought to maximize our insurance recovery.

"In fact, when you figure in insurance money, that \$10-million business-interruption insurance we purchased a couple months before the hurricane meant that our gaming revenue was actually a little above the '04 levels. And, if you include the insurance money, our overall revenue was only 3 percent off."

The city, which had seen 60 percent of its annual pre-Katrina revenue generated by gaming and sales taxes, has seen those categories rebound strongly in the 20 months since the storm.

In fact, in September, the city's casinos grossed

more money than any other month in history, followed by the largest October, November, December, February and March on record.

Since the storm, sales taxes have grown to 85 percent of their pre-Katrina levels, and "we expect sales tax to be down again in 2007, pending the rebuilding of more of our restaurants and other amenities. And we'll see more and more of these amenities building back because of those gaming numbers I mentioned.

"That means more jobs, more people working and enhancing our tax base, which is why we have not raised your city property taxes in Biloxi NOT ONE TIME in the past 15 years."

The city was also able to recover 99.4 percent of its \$30 million in insurance coverage.

Holloway noted that the full brunt of the storm damage will be reflected in property taxes collected this year.

"To be honest, the operating revenue we receive from your property taxes will be severely reduced in 2007 because the city lost 30 percent of its assessed value. We are not out of the woods by far."
