RESOLUTION ADJUSTING COMPENSATION FOR DEPARTMENT DIRECTORS

WHEREAS, the Mayor of the City of Biloxi has previously appointed directors for each municipal department, and those directors were confirmed by the City Council; and

WHEREAS, in conjunction with and subsequent to those appointments, salaries were set for each director in Resolution 459-16; and

WHEREAS, it is appropriate at this time to make adjustments to certain said salaries for the Fiscal Year 2018-2019 to authorize an increase for certain directors such that salary amount is consistent with education, experience and responsibilities.

NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BILOXI, MISSISSIPPI as follows:

SECTION 1. The findings, conclusions, and statements of fact contained in the foregoing preamble are hereby adopted, ratified and incorporated herein.

SECTION 2. Along with all benefits as provided by law and City policy, the salaries of the following municipal officials are established, effective for the first pay period ending in October 2018, as follows:

- (A) Billy Allen, Director of Public Works Department: \$80,000.00
- (B) Cheryl Bell, Director of Parks and Recreation Department: \$77,000.00
- (C) Christy LeBatard, Director of Engineering Department: \$ 80,000.00

All other director salary amounts to remain as currently authorized.

SECTION 3. This resolution shall take effect and be in force from and after adoption.
