RESOLUTION REAPPOINTING JOHN D. SNOW, WARD SEVEN REPRESENTATIVE TO
THE BILOXI PLANNING COMMISSION FOR A TERM BEGINNING FEBRUARY 3, 2019
AND ENDING FEBRUARY 2, 2023

WHEREAS, Section 23-2-2 of the Land Development Ordinance of the Code of Ordinances, City of Biloxi, Mississippi, of 1992, as amended, provides the establishment of the City of Biloxi Planning Commission, all of whom shall be resident citizens of the city and qualified electors therein; and

WHEREAS, John D. Snow's term as the Ward Seven representative has expired and said member desires to continue serving; and

WHEREAS, John D. Snow, Ward Seven representative, is appointed by the Mayor and recognized by the Council as a qualified and proper person to fill said term beginning February 3, 2019 and ending February 2, 2023; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BILOXI, MISSISSIPPI:

Section 1: The findings, conclusions and statement of fact contained in the preamble are hereby adopted, ratified and incorporated herein.

Section 2: The reappointment of John D. Snow, Ward Seven representative, to the Biloxi Planning Commission, for a term beginning on February 3, 2019, and February 2, 2023, be and hereby is confirmed.
