RESOLUTION AMENDING THE MUNICIPAL BUDGET FOR THE FISCAL YEAR TO  
END SEPTEMBER 30, 2019 TO TRANSFER APPROPRIATIONS FROM THE  
GENERAL FUND TO EXECUTIVE DEPARTMENT

WHEREAS, Section 21-35-25 Mississippi Code of 1972 provides authorization for the governing authorities of a municipality to amend the budget if it affirmatively appears at any time during the current fiscal year that there is in any account any sum remaining unexpended and not needed for the purpose for which appropriated in said budget; and,

WHEREAS, Mike Leonard, Chief Administrative Officer, finds it necessary to increase Convention/Conferences/Training to be used for expected expenditures in Executive Departments and

WHEREAS, Mike Leonard, Chief Administrative Officer, has recommended that the Municipal Budget for the fiscal year ending September 30, 2019 be amended to transfer appropriations from the City's General Fund to Executive Budget, 01211-6672, namely Convention/Conferences/Training in the amount of \$20,000.00;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BILOXI, MISSISSIPPI, THAT:

Section 1: The findings, conclusions and statements of fact contained in the preamble are hereby adopted, ratified and incorporated herein.

Section 2: The Municipal Budget of the City of Biloxi General Fund for the fiscal year to end September 30, 2019 is hereby amended to transfer expenditure appropriation from the General Fund to Executive Budget, 01211-6672, namely Convention/Conferences/Training in the amount of \$20,000.00 attached as Exhibit "A".

Section 3: This resolution shall take effect and be in force from and after adoption.


