WHEREAS, during the month of April, the City Council meeting times will change for the third and fourth Tuesdays as follows: on April 19, 2022, at 4:00 p.m. and April 26, 2022, at 4:00 p.m.

WHEREAS, during the month of May, the City Council meeting times will change for the third and fourth Tuesdays as follows: on May 17, 2022, at 4:00 p.m. and May 24, 2022, at 4:00 p.m.
