RESOLUTION AUTHORIZING A BUDGET AMENDMENT FOR THE
FISCAL YEAR ENDING SEPTEMBER 30, 2024, MUNICIPAL BUDGET
FOR THE PARKS AND RECREATION DEPARTMENT

WHEREAS, Section 21-35-25 Mississippi Code of 1972 provides authorization for the governing authorities of a municipality to amend the budget if it affirmatively appears at any time during the current fiscal year that there is in any account any sum remaining unexpended and not needed for the purpose for which appropriated in the said budget;

WHEREAS, the City of Biloxi will be hosting the Martin Luther King Jr. Day Celebration to be held on January 13, 2024;

WHEREAS, the MLK Celebration line item has funds in the amount of \$10,000.00;

WHEREAS, the Parks and Recreation Department is in need of the funds to host the Martin Luther King Jr. Day Celebration;

WHEREAS, it is necessary to amend the FY 2023-2024 Parks and Recreation Budget to provide appropriation for use towards the Martin Luther King Jr. Day Celebration;

WHEREAS, that the FY 2023-2024 Parks and Recreation Budget be amended by transferring \$10,000.00 from line-item No. 01822-6649-ND142, namely MLK Celebration, and increasing line item 01411-6649, namely Other Contractual Services in the amount of \$10,000.00.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF BILOXI, MISSISSIPPI, AS FOLLOWS:

SECTION ONE: The findings, conclusions, and statements of facts contained in the preamble of this are hereby approved, adopted, and ratified.

SECTION TWO: The Parks and Recreation Budget for Fiscal Year ending September 30, 2024, be and is hereby amended by transferring \$10,000.00 from line-item No. 01822-6649-

ND142, namely MLK Celebration, and increasing line item 01411-6649, namely Other Contractual Services in the amount of \$10,000.00.

SECTION THREE: This Resolution shall take effect and be in force from and after adoption.
