RESOLUTION CREATING CAPITAL PROJECT NO. 1111: CAUSEWAY PIER REMOVAL  
AND REPAIRS

WHEREAS, pursuant to Section 21-37-13, Mississippi Code of 1972, the City of Biloxi (the "City") is authorized to expend funds to own, operate, and regulate, piers, pavilions, bath houses, and other like appropriate structures;

WHEREAS, sections of a pier in the Poppo Ferry Causeway Park were severely damaged in Tropical Storm Cristobal;

WHEREAS, is it in the best interest of the City to create Capital Project 1111: Causeway Pier Removal and Repairs ("Project 1111"), for the purposes of removing the severely damaged sections of the pier in the Poppo Ferry Causeway Park and repairing the salvable sections;

WHEREAS, funding for Project 1110 will be allocated by separate and concurrent resolution at this time; and

WHEREAS, it is the recommendation of Christy LeBatard, Director of Engineering, that Project 1111 be created for the reasons stated herein.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF BILOXI, MISSISSIPPI, AS FOLLOWS:

SECTION ONE: The findings, conclusions, and statements contained in the preamble of this are hereby approved, adopted, and ratified.

SECTION TWO: Capital Project 1111: Causeway Pier Removal and Repair is hereby created for the purpose of removing the severely damaged sections of the pier in the Poppo Ferry Causeway Park and repairing the salvable sections.

SECTION THREE: This Resolution shall take effect and be in force from and after adoption.
