RESOLUTION APPOINTING CONNIE ROCKCO TO
THE BILOXI BEAUTIFICATION COMMISSION FOR A TERM
BEGINNING DECEMBER 2, 2025 AND ENDING DECEMBER 1, 2028

WHEREAS, pursuant to Section 2-6-1 of the Code of Ordinances, City of Biloxi, Mississippi, of 1959, as amended, provides for the creation of the Beautification Commission; and

WHEREAS, Section 2-6-2 requires the appointment of seven (7) members to the Beautification Commission, all of whom shall be resident citizens of the City and qualified electors therein; and

WHEREAS, it is necessary to appoint seven (7) persons to serve as members of the Beautification Commission; and

WHEREAS, there are three (3) vacancies for the Beautification Commission; and

WHEREAS, Connie Rockco has a demonstrated track record of leadership in beautification initiatives, including instrumental leadership in Harrison County's Beautification Commission, which aligns with the goals and duties of the Biloxi Beautification Commission.

WHEREAS, members of the Beautification Commission are directly appointed by City Council and Connie Rockco is recognized by the Council as a qualified and proper person to fill said position for a term of three (3) years, beginning December 2, 2025, and ending December 1, 2028.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF BILOXI, MISSISSIPPI, THAT:

SECTION ONE: The findings, conclusions, and statements of fact contained in the preamble are hereby adopted, ratified, and incorporated herein.

SECTION TWO: The City Council's appointment of Connie Rockco, who is not an officers or employee of the City of Biloxi, Mississippi, to serve as a member of the Beautification

Commission for the term beginning December 2, 2025, and ending December 1, 2028, be and hereby is appointed and approved.

SECTION THREE: This resolution shall take effect and be in force from and after adoption.
