RESOLUTION REQUESTING THE ADMINISTRATION TO CREATE A PROJECT ACCOUNT FOR EACH OF THE SEVEN WARDS FOR FUNDS RECEIVED FROM THE MISSISSIPPI DEPARTMENT OF REVENUE PURSUANT TO THE PROVISIONS OF THE MISSISSIPPI INFRASTRUCTURE MODERNIZATION ACT OF 2018

WHEREAS, in accordance with the provisions of the Mississippi Infrastructure Modernization Act of 2018 (the "Act"), as codified in §27-67-31 of the Mississippi Code of 1972, the City of Biloxi (the "City") has received the sum of Two Million Two Hundred Fifty-Nine Thousand Three Hundred Ninety-Seven and 04/100 Dollars (\$2,259,397.04) from the Mississippi Department of Revenue;

WHEREAS, such funds must be expended by municipalities in accordance with the Act, for repair, maintenance and/or reconstruction of roads, streets, bridges, water infrastructure or sewer infrastructure;

WHEREAS, a project account will be created for each of the seven wards to allow each Council Member to have funding for repairs;

WHEREAS, funds received from the Mississippi Department of Revenue in accordance with the provisions of the Mississippi Infrastructure Modernization Act of 2018 shall be placed in the accounts created for each of the seven wards for current funds and future funds received until June 30, 2029.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF BILOXI, MISSISSIPPI, THAT:

SECTION ONE: The findings, conclusions, and statements of fact contained in the foregoing preamble are hereby adopted, ratified and incorporated herein.

SECTION TWO: The Administration create a project account for each of the seven wards to allow each Council Member to have funding for repairs.

SECTION THREE: Funds received from the Mississippi Department of Revenue in accordance with the provisions of the Mississippi Infrastructure Modernization Act of 2018 shall be placed in the accounts created for each of the seven wards for current funds and future funds received until June 30, 2029.

SECTION FOUR: This resolution shall take effect and be in force from and after adoption.
