RESOLUTION REAPPOINTING GEORGE BIRDROW TO THE  
BILOXI HOUSING AUTHORITY BOARD FOR THE TERM  
BEGINNING FEBRUARY 15, 2026 AND ENDING FEBRUARY 14, 2031

WHEREAS, Section 43-33-7, Mississippi Code of 1972, as amended, establishes the Housing Authority Board for the City of Biloxi; and

WHEREAS, George Birdrow's term of office on the Biloxi Housing Authority Board will expire and said member desires to continue serving; and

WHEREAS, George Birdrow is reappointed by the Mayor and recognized by the Council as a qualified and proper person to fill the term beginning February 15, 2026 and ending February 14, 2031.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF BILOXI, MISSISSIPPI:

Section 1: The findings, conclusions and statements of fact contained in the preamble are hereby adopted, ratified and incorporated herein.

Section 2: That the reappointment of George Birdrow who is not an officer or employee of the City of Biloxi, Mississippi, to serve as a Commissioner of the Housing Authority of the City of Biloxi for a term beginning February 15, 2026 and ending February 14, 2031, be and hereby is confirmed.

Section 3: This resolution shall take effect and be in force from and after adoption.
