RESOLUTION ADJUSTING COMPENSATION FOR

WHEREAS, in conjunction with and subsequent to those appointments, salaries were set for each director; and

WHEREAS, it is the recommendation of the Mayor to make an adjustment to said salary for the Director of the Community Development Department;

NOW, THEREFORE BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF BILOXI, MISSISSIPPI AS FOLLOWS:

SECTION ONE: The findings, conclusions, and statements of fact contained in the foregoing preamble are hereby adopted, ratified and incorporated herein.

SECTION TWO: Along with all benefits as provided by law and City policy, the salary of the Director of the Community Development Department shall be \$96,250.00 and shall be effective upon passage of this resolution.
