RESOLUTION APPOINTING JEFFREY ELLIS TO SERVE ON THE MOTOR VEHICLE FOR HIRE AUTHORITY AS THE CITY OF BILOXI REPRESENTATIVE FOR THE UNEXPIRED TERM BEGINNING JUNE 2, 2026 AND ENDING MAY 20, 2027

WHEREAS, pursuant to the Second Amended and Restated Interlocal Governmental Cooperation Agreement among the City of Gulfport, City of Biloxi, and the City of D'Iberville for the Cooperation in the Regulation of Motor Vehicles for Hire and Other Related Purpose (the "ILA"), effective July 10, 2018, each of the participating municipalities must appoint and confirm one (1) representative to the Motor Vehicles for Hire Authority ("MVFHA"); and

WHEREAS, due to the resignation of Matthew Langlinais a vacancy exists on said board; and

WHEREAS, Jeffrey Ellis is hereby appointed by the Mayor and recognized by the Council as a qualified and proper person to serve on the MVFHA for the unexpired term beginning June 2, 2026, and ending May 20, 2027 or until a successor is appointed.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF BILOXI, MISSISSIPPI, THAT:

Section 1: The findings, conclusions, and statements of fact contained in the foregoing preamble are hereby adopted, ratified, and incorporated herein.

Section 2: The appointment of Jeffrey Ellis to serve on the Motor Vehicle for Hire Authority, as the City of Biloxi's representative, for the unexpired term beginning June 2, 2026, and ending May 20, 2027, or until a successor is appointed, is hereby confirmed.

Section 3: This resolution shall take effect and be in force from and after adoption.
