RESOLUTION AMENDING THE FIRE DEPARTMENT BUDGET FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 2026, TO TRANSFER APPROPRIATIONS IN THE AMOUNT OF \$23,000 IN REBATE FUNDS TO BE USED FOR TRAINING PURPOSES.

WHEREAS, Section 21-35-25 Mississippi Code of 1972 provides authorization for the governing authorities of a municipality to amend the budget if it affirmatively appears at any time during the current fiscal year that there is in any account any sum remaining unexpended and not needed for the purpose for which appropriated in said budget; and

WHEREAS, the Fire Department is in need of training classes; and

WHEREAS, Nick Geiser, Director of Fire, has recommended that the Municipal Budget for the Fiscal Year ending September 30, 2026, be amended by transferring appropriations from 05558-6800, namely Machinery/Equipment in the amount of \$23,000 into 05558-6672, namely Convention/Conference/Training for the payment of training classes.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF BILOXI, MISSISSIPPI, AS FOLLOWS:

SECTION ONE: The findings, conclusions, and statements of fact contained in the preamble are hereby adopted, ratified, and incorporated herein.

SECTION TWO: The Fire Budget for the fiscal year to end September 30, 2026 is hereby amended to transfer expenditure appropriation from 05558-6800, namely Machinery/Equipment in the amount of \$23,000 into 05558-6672, namely Convention/Conference/Training.

SECTION THREE: This resolution shall take effect and be in force from and after adoption.
