RESOLUTION AUTHORIZING SUBMISSION OF A GRANT APPLICATION TO THE MISSISSIPPI DEPARTMENT OF MARINE RESOURCES FOR TIDELANDS FUNDING TO BE UTILIZED IN CONNECTION WITH ADDITIONAL BRASHER BAYOU DREDGING

WHEREAS, the City of Biloxi (the "City") has identified a need for additional dredging in Brasher Bayou;

WHEREAS, the City is eligible to receive funding from the Mississippi Department of Marine Resources (the "MDMR") under the Tidelands grant program, which has been established to improve public access to marine resources;

WHEREAS, it is in the best interest of the City to submit the grant application, in substantially the form attached hereto as Exhibit "A," requesting funding in the amount of Four Hundred Thousand and 00/100 Dollars (\$400,000.00) from MDMR with no required match from the City;

WHEREAS, if awarded, the requested funding will be utilized by the City to re-establish suitable navigable channels by increasing the waterways depth and width in Brasher Bayou and restore adequate stormwater runoff while providing for safe navigation of waterways for recreational boaters and fisherman; and

WHEREAS, it is the recommendation of Christy LeBatard, Director of Engineering, that the City submit the request for funding described herein to MDMR.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING AUTHORITIES OF THE CITY OF BILOXI, MISSISSIPPI, THAT:

SECTION ONE: The statements, findings, determinations and conclusions contained in the preamble of this resolution are hereby adopted, ratified and incorporated herein.

SECTION TWO: The Mayor, on behalf of the City of Biloxi, is authorized to execute the grant application, in substantially the form attached hereto as Exhibit "A," to the Mississippi Department of Marine Resources, requesting grant funding in the amount of Four Hundred Thousand and 00/100 Dollars (\$400,000.00), with no required match from the City of Biloxi.

SECTION THREE: The Mayor, or his designee, is hereby authorized to take any and all actions necessary to carry out the intent of this resolution and to provide any information required by Mississippi Department of Marine Resources in order to complete its review of said application.

SECTION FOUR: This resolution shall take effect and be in force from and after adoption.

Continued siltation from storm water runoff, impact from storm surge, normal wave action and accumulated debris have contributed to the shallow water depths within these nearshore areas. The shallowing of these waterways is impacting safe recreational usage and increasing the waterways depth and width, will restore adequate stormwater runoff, safe navigation of waterways and provide enhanced recreational opportunities to access a Tidelands area.
