RESOLUTION APPOINTING RHETT TAYLOR TO
THE BILOXI BEAUTIFICATION COMMISSION FOR THE UNEXPIRED
TERM BEGINNING JUNE 23, 2026 AND ENDING DECEMBER 1, 2028

WHEREAS, pursuant to Section 2-6-1 of the Code of Ordinances, City of Biloxi, Mississippi, of 1959, as amended, provides for the creation of the Beautification Commission;

WHEREAS, Section 2-6-2 requires the appointment of seven (7) members to the Beautification Commission, all of whom shall be resident citizens of the City and qualified electors therein;

WHEREAS, due to the resignation of Connie Rockco a vacancy exists on said board;

WHEREAS, members of the Beautification Commission are directly appointed by City Council and Rhett Taylor is recognized by the Council as a qualified and proper person to fill said position for the unexpired term, beginning June 23, 2026, and ending December 1, 2028.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF BILOXI, MISSISSIPPI, THAT:

SECTION ONE: The findings, conclusions, and statements of fact contained in the preamble are hereby adopted, ratified, and incorporated herein.

SECTION TWO: The City Council's appointment of Rhett Taylor, who is not an officer or employee of the City of Biloxi, Mississippi, to serve as a member of the Beautification Commission for the unexpired term beginning June 23, 2026, and ending December 1, 2028, be and hereby is appointed and approved.

SECTION THREE: This resolution shall take effect and be in force from and after adoption.
