RESOLUTION REAPPOINTING EULA CROWELL
TO THE BILOXI HOUSING AUTHORITY BOARD FOR A TERM
BEGINNING JULY 20, 2026 AND ENDING JULY 19, 2031

WHEREAS, Section 43-33-7, Mississippi Code of 1972, as amended, establishes the
Housing Authority Board for the City of Biloxi; and

WHEREAS, Eula Crowell's term of office on the Biloxi Housing Authority Board has
expired and said member desires to continue serving; and

WHEREAS, Eula Crowell is reappointed by the Mayor and recognized by the Council as a
qualified and proper person to fill a term beginning July 20, 2026 and ending July 19, 2031.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF
THE CITY OF BILOXI, MISSISSIPPI:

Section 1: The findings, conclusions and statements of fact contained in the preamble are
hereby adopted, ratified and incorporated herein.

Section 2: That the reappointment of Eula Crowell who is not an officer or employee of
the City of Biloxi, Mississippi, to serve as a Commissioner of the Housing Authority of the City of
Biloxi for a term beginning July 20, 2026 and ending July 19, 2031, be and hereby is confirmed.

Section 3: This Resolution shall take effect and be in force from and after adoption.
