RESOLUTION AUTHORIZING MET LIFE INSURANCE
TO PROVIDE EMPLOYEES WITH DENTAL INSURANCE BENEFITS

WHEREAS, the City of Biloxi has received a proposal for dental benefits from Met Life Insurance with a 2 (two) year rate guaranteed at the rates of employee only \$28.92, employee/spouse of \$57.40 per month, employee/children of \$69.20 per month and employee/family \$106.94 per month; and

WHEREAS, it is in the best interest of the City of Biloxi to provide dental benefit coverage for employees and their dependents, at the employees' contribution amount of \$14.46 per month, (employee and) spouse contribution of \$42.94 per month, (employee and) children contribution of \$54.74 per month and (employee and) family contribution \$92.48 per month; and NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL FOR THE CITY OF BILOXI, MISSISSIPPI, THAT:

SECTION 1: The statements and conclusions contained in the preamble of this resolution are hereby approved, adopted, and ratified.

SECTION 2: The Mayor and/or Municipal Clerk be and are hereby authorized to enter into and execute the necessary documents with Met Life Insurance to obtain dental insurance benefits for the City of Biloxi employees and their dependents.

SECTION 3: The Mayor and/or Municipal Clerk be and are hereby authorized to enter into and execute the necessary documents to provide dental coverage with a 2 (two) year rate guaranteed; at the rate of employee only \$28.92, employee/spouse of \$57.40 per month, employee/children of \$69.20 per month, and employee/family \$106.94 per month.

SECTION 4: The term of the dental insurance coverage with Met Life Insurance will begin October 1, 2026, ending September 30, 2028.

SECTION 5: This resolution shall take effect and be in force from and after adoption.
