RESOLUTION APPOINTING JAMES B. “BERNIE” MARINOVICH TO THE BILOXI
ARCHITECTURAL AND HISTORICAL REVIEW COMMISSION FOR A TERM
BEGINNING SEPTEMBER 22, 2026 AND ENDING SEPTEMBER 21, 2030

WHEREAS, Section 23-2-4 of the Code of Ordinances, City of Biloxi, Mississippi of 1992, as amended, establishes an architectural and historic review commission known as the Biloxi Architectural and Historical Review Commission, which shall consist of nine (9) appointed members to be appointed for a four (4) year term; and

WHEREAS, a vacancy exists on said board; and

WHEREAS, James B. “Bernie” Marinovich is appointed by the Mayor and recognized by the Council as a qualified and proper person for a term beginning September 22, 2026 and ending September 21, 2030.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF BILOXI, MISSISSIPPI:

Section 1: The findings, conclusions and statements of fact contained in the preamble are hereby adopted, ratified and incorporated herein.

Section 2: That the appointment of James B. “Bernie” Marinovich to serve as a member on the Biloxi Architectural and Historical Review Commission for a term beginning September 22, 2026 and ending September 21, 2030, be and hereby is confirmed.

SECTION 3: This resolution shall take effect and be in force from and after adoption.
