and constructed in accordance with the approvals	granted by the City. This Certificate is part of the overall				

post-development approval process.

Please note: A CDC shall be required before a Certificate of Occupancy is issued for any building or use within the development, section of a development, including such building or use, or before Final Plat approval in the case of a subdivision, unless a guarantee of improvement has been posted in accord with this Chapter. If a guarantee of improvement has been posted, a CDC shall be required before the guarantee will be released. All development with the exception of a single family residential unit will require the issuance of a CDC.
