





Last week in Community Development, the public hearing regarding the zoning change application for property surrounding the Margaritaville Resort was continued for an additional two weeks. The continuance was requested to provide sufficient time for the Margaritaville developers and the Secretary of State to continue negotiations for a lease on the property. The developers are proposing a \$140 million dollar, family-oriented amusement development for the property involved in the zoning change.

Also, the Development Review Committee approved a site plan for Campers World RV Center for a multi-million dollar expansion of their existing facility located at the southeast corner of Shriners Boulevard and I-10. The proposed expansion will include construction of a new sales structure that faces the intersection. A site plan was also approved for the proposed Beach View Villas, a 124 unit apartment complex to be located on Grand View Drive near Beach Boulevard.

Building plan reviews were completed last week for the Watermark Hotel, formerly the Santa Maria Del Mar, a 154 unit conversion, and for the La Quinta Inn & Suites which is to be located at Beach Boulevard and Hopkins. Permits were issued last week for the site work for Campers World and for three single family homes.
